### Description of alleged violation:

Tbelieve an intentional violation of the Open Meeting Law occurred. The 3 defendants met either in person or electronically, worked with a group of individuals including an abutter attorney to draft an amendment related to a proposed Waubeeka Golf Club Inn project. They did so outside an open meeting. At a Board meeting on 4/28/16, a meeting was scheduled for 5/4/16 to finalize agreements made at the 4/28 meeting. During that week, the defendants crafted the "Gardner Amendment", allegedly co-authored by Gardner & McCallum. In the first minutes of the 5/4 meeting, McGowan introduced this amendment stunning the other 2 Planning Board members. Gardner, McCallum, and McGowan are all employees of Williams College. The Waubeeka Inn proposal is by its nature a competitor to an Inn to be built by Williams College and before their Board. The 3 voted to expand the Spring Street Business District to allow their employer to build an Inn on Spring Street. Despite a negative environmental impact study introduced, no conditions were imposed upon the Williams College project. The Gardner Amendment places significant obstacles to the Waubeeka Inn project which make it likely to fail at Town Meeting. Public comments by others say the 3 worked outside intent of the law. McGowan's immediate motion on 5/4 introduced the amendment as written and that could not occur unless she knew of its content, which would involve the 3 sharing the document in question. Gardner, McCallum & McGowan form a quorum of this 5 person board, and there is clear bias toward the Waubeeka Inn project which is a competitor to the Spring Street Inn project of their employer. The amendment is too sophisticated, and its introduction and passage by the 3 clearly indicate a possible Open Meeting Law violation
